Dear Sir or Madam,

The TUM University Library requests, pursuant to § 18 para. 3 sentence 2 of the General Regulations on the Use of Bavarian State Libraries (Allgemeine Benützungsdordnung der Bayerischen Staatlichen Bibliotheken, ABOB), that you return borrowed library items within one week from the date of the original letter sent to you by email. The items to be returned are listed in the annex to this letter.

If you fail to return the respective items properly and within one week from the date of the original letter sent to you by email, the TUM University Library will issue a third return request, subject to additional fees, pursuant to § 18 para. 4 sentence 1 ABOB. All resulting costs will be borne by you.

**A fee of €10.00** is charged for this return request amounts, payable within four weeks from the date of the original letter sent to by email.

Your library account will remain blocked until the respective items have been returned and all outstanding fees have been settled.

**Reasons**

The due dates for the respective items are indicated on your loan receipts. The loan periods for the items listed in the annex to the original letter have expired.

Although, pursuant to § 18 para. 1 ABOB, you are obligated to return borrowed items on time, no later than on the respective due date, you did not meet the return deadlines known to you. Therefore, the TUM University Library issued a return request, subject to fees, pursuant to § 18 para. 3 sentence 1 ABOB.

You did not comply with this return request. Therefore, the TUM University Library issues a second request, pursuant to § 18 para. 3 sentence 2 ABOB, requiring you to fulfill your obligation to return the borrowed items within one week from the date of the original letter sent to you by email.

The charging of the above-mentioned fees is based on § 12 para. 5 ABOB in conjunction with Art. 1 para. 1 sentence 1, Art. 2 para. 1 sentence 1, Art. 5 para. 1 sentence 2 no. 4, and Art. 6 para. 1 sentence 1 of the Bavarian Costs Law (Kostengesetz, KG) in conjunction with tariff no. 3/III.2/7 of the Bavarian Schedule of Costs (Kostenverzeichnis, KVz).

The blocking of your library account is based on § 18 para. 8 ABOB.
