**Third Request for the Return of Borrowed Items  
to the University Library of the Technical University of Munich (TUM)  
pursuant to § 18 para. 4 sentence 1 of the General Regulations  
on the Use of Bavarian State Libraries (ABOB)**

Dear Sir or Madam,

The TUM University Library request, pursuant to § 18 para. 4 sentence 1 of the General Regulations on the Use of the Bavarian State Libraries (Allgemeine Benützungsbildung der Bayerischen Staatlichen Bibliotheken, ABOB), that you return the borrowed library items within one week from the date of the original letter sent to you by postal mail. The items to be returned are listed in the annex to this letter.

If you fail to return the respective items properly and **within one week from the date of the original letter** sent to you by postal mail, the TUM University Library will, pursuant to § 18 para. 4 sentence 2 ABOB,

- a) temporarily suspend your user privileges at the university library, and
- b) issue an administrative notice, subject to charges, pursuant to § 18 para. 5 sentence 1 ABOB, ordering the return of the borrowed items and declaring its immediate enforceability, or
- c) consider the respective items lost and claim reasonable compensation from you, pursuant to § 18 para. 6 and § 8 para. 3 ABOB).

All resulting costs will be borne by you. Your library account will remain blocked until you have returned the respective items or, where applicable, you have paid compensation for damages.

### **Reasons**

The due dates for the respective items are indicated on your loan receipts. The loan periods for the items listed in the annex to the original letter have expired.

Although, pursuant to § 18 para. 1 ABOB, you are obligated to return borrowed items on time, no later than respective on the due date, you did not meet the return deadlines known to you. Therefore, the TUM University Library previously issued fee-based return requests for the respective items, pursuant to § 18 para. 3 sentences 1 and 2 ABOB.

You did not comply with these previous return requests. Therefore, the TUM University Library issues a third request, pursuant to § 18 para. 4 sentence 1 ABOB, requiring you to fulfill your obligation to return the borrowed items within one week from the date of the original letter sent to you by postal mail.

Notice of further procedures in the event of failure to return library items, the threat of exclusion from the use of the library, and the blocking of your library account are based on § 18 para. 4 sentence 2 and para. 8 ABOB.

The charging of the above-mentioned fees and expenses is based on § 12 para. 5 ABOB in conjunction with Art. 1 para. 1 sentence 1, Art. 2 para. 1 sentence 1, Art. 5 para. 1 sentence 2 no. 4, Art. 6 para. 1 sentence 1, and Art. 10 para. 1 no. 2 of the Bavarian Costs Law (Kostengesetz, KG) in conjunction with tariff no. 3/III.2/8 of the Bavarian Schedule of Costs (Kostenverzeichnis, KVz).
